## THE MAYOR OF LONDON'S ENERGY EFFICIENCY FUND (MEEF)

*MEEF* is an investment fund, established by the GLA with funding from the European Commission, which will help achieve London's ambition of being a zero carbon city by 2050.

The Fund is managed by Amber Infrastructure Group.

## MEEF

- MEEF has been developed to support the Public Sector transition to low carbon vehicles.
- MEEF has access to £500m of financing that can provide funding for up to 100% of the capital cost of a project.
- MEEF can provide competitive flexible loans for 15 years and already has template loan documentation for the Public Sector.
- MEEF can provide framework loans. locking into a fixed interest rate, while allowing drawdowns over the period to 31 May 2024.
- MEEF can either lend directly to a Public Sector organisation or to a Special Purpose Vehicle established by an SME that provides charging for a Public Sector client.
